* All items must be CLEAN, free of odor, pet hair and in "Ready to Sell" condition.
Items requiring cleaning, repair, bulbs or batteries will be charged at \$1 /minute + supplies.

CONSIGNMENT PERIOD: 9 weeks. *Items picked up before the end of the contract subject to \$25 early retrieval fee. Furniture option @ WSS discretion.: 2-week extension @ 1/2 OFF w/ 30% by check or 40% store credit. Prior approval req'd: _____ (WSS initial) Denied: _____ (WSS initial)*

EXPIRED ITEMS: If items have not sold by the end of your consignment period:
 Donate items (or as indicated on inventory sheet.)
